## Product Description

NATtrol™ **CMV External Run Controls** are formulated with intact CMV particles that have been chemically modified to render them non-infectious and refrigerator stable\*. Each run control pack contains 6 x 1 mL vials of CMV NATtrol™ at either 5,000 copies/mL (NATCMV-ERCL) or 50,000 copies/mL (NATCMV-ERCM). These controls are supplied in a purified serum protein matrix that mimics the composition of a true clinical specimen. External Run Control formulations are validated using an in-house real time PCR assay targeting the CMV *pol* gene. Copies/mL were calibrated against commercially available quantities of CMV DNA.

## Intended Use

- NATtrol™ CMV External Run Controls are full process controls designed to validate the extraction and amplification of CMV in human serum or plasma. Controls should be run using the same protocols as those used to run clinical specimens. **NATtrol™ CMV controls must be extracted prior to amplification.**

## Etiologic Status/Biohazard Testing

- NATtrol™ inactivation was carried out on the CMV in each control. The inactivation was measured by following the absence of viral growth in validated tissue culture based infectivity assays.
- The purified serum protein matrix was sourced from licensed U.S. blood banks and screened negative for HIV 1&2 Ab, HBsAg, HTLV I&II Ab, HCV Ab, HIV RNA, HBV DNA and HCV RNA using FDA cleared kits at the single donor level.
